

Aquatic Invasive Species Regulations

- ◆ The transport of all aquatic plants, plant parts, or other aquatic invasive species (i.e. zebra mussels, spiny water flea) to or from any Vermont surface water is illegal.
- ◆ Prior to transporting or launching a vessel to or from a waterbody, inspect the vessel, trailer, vehicle, equipment, etc. to remove and dispose of **ANY plant or plant parts**.
- ◆ All vessels, trailers, and transport vehicles must be inspected and decontaminated if a boat washing station is present, staffed, and an inspector deems decontamination is necessary.
- ◆ Prior to leaving a boat ramp the vessel, trailer, live wells, and bilge tanks must be drained and drain plugs must remain out during transportation.

Any person who violates this law may be subject to a fine of up to \$1,000 per violation.

Boating Safety Checklist

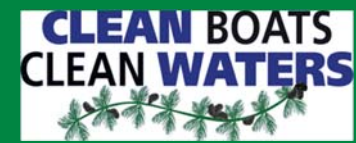
- ✓ Weather conditions safe for boating
- ✓ Map of boating location & known hazards
- ✓ Informed of rules for a given waterbody
- ✓ Access area signage reviewed for updates
- ✓ Valid registration stickers and cards
- ✓ US Coast Guard (USCG) approved PFD onboard for each person
- ✓ Properly working safety equipment including; USCG approved fire extinguisher, throwable device, horn, whistle, and/or bell

Boating Safely on Vermont Waters

The number and variety of recreational uses on Vermont waters can sometimes lead to conflict. Learning and following the rules allows everyone to safely enjoy time in and on the water.



Boating Etiquette

- ◆ When launching and transporting your boat, keep the launch or travel lanes open
- ◆ Maximize parking at all times
- ◆ Operate watercraft in a careful and responsible manner
- ◆ Use caution when in populated areas and stay right when meeting other boats
- ◆ Always respect private property
- ◆ Regularly maintain your boat for your safety and to prevent gas and oil spills
- ◆ Clean, drain, and dry your boat before entering and after exiting the water

A Splash of Vermont Boating Regulations

Local, State, and Federal Restrictions apply to all waterways in Vermont. Prior to boating, check with the appropriate officials to become aware of the regulations for the waterbody you are visiting to keep you and others safe. At state launches, pertinent laws will be posted on the kiosk.

Vermont Boating Regulations

- ✦ A US Coast Guard (USCG) approved Personal Floatation Device (PFD) must be onboard for each occupant
- ✦ Vessels shall be operated at a no wake speed (or 5 mph) within 200' of the shore
- ✦ Vessels may not be operated faster than 5 mph within 200' of people, wildlife, other watercraft, docks, or swimming areas
- ✦ Anyone towed by a boat must wear a USCG approved PFD and the boat must have a spotter over the age of 12
- ✦ All navigational rules when encountering other vessels must be followed
- ✦ Trash and any potentially hazardous materials must be disposed of properly
- ✦ Make sure you have the appropriate safety gear to comply with your Vessel's Length Class
