**Committee reports:**

- **Boat Wash/Trailer – Cori**
  - Trailer team is being put together for the summer, 2025
  - Training notifications have not been posted
- **SLASPP – Jen**
  - Leann Harple, State Representative, has put together a petition for communities to be responsible for their lake
  - Reclassification petition – on hold
  - RWVL – trying to work with new lakes manager and Fish and Wildlife plus others to determine what DEC will do
  - Wake boat petition – Shadow Lake – on hold
  - Deltaic mounds – Chrissy Cano has set up a meeting with state individuals on April 9 to discuss the deltaic mound issue (sediment that comes down into the lake from resident properties/road)
    - Jen indicated that there are photos of the sediment build up
    - Steve – land owners should be available to make comments first
    - Cori – state representatives should come and look at the sediment deposits
  - Lakewise – how to increase participation in this program – **Jen/Linda**
    - Jen is going to put together a mailchimp on how important for residents to participate in the Lakewise program.
- **Dam – Steve/David**
  - Steve indicated that they may start ‘boring’ on the lake but unsure of the initiation date
  - Town of Glover has had 2 or 3 fundraising events
  - Events posted on Town of Glover website

- SLA may want to develop some fundraising events; refer to Front Porch Forum for information on fundraising events
  - Townwide bottle drive and commit bottle collection towards support of the dam
